2. RESERVATION FOR PHYSICALLY CHALLENGED PERSONS :-

2.1 As per G.R., Medical Education and Drug Dept. No.MES-1202/(81) / MES - 1, dt. 19 th August, 2005, Physically Challenged Candidates are not eligible for the subject Anaesthesiology.

2.2 Eligibility / Non-eligibility of sub-categories of Physically Challenged Candidates for the remaining subjects is mentioned below.

3. **PAY:- Rs.37400- 67000 + G.P.Rs.10000/- (T.E.approximately Rs.75518/-)** plus other admissible allowances as per prevalent Rules.

4. **AGE :-**

4.1 Not more than 40 years as on 1st June, 2010. Relaxable as per Rules..

4.2 The upper age limit shall not apply to employee of Government of Maharashtra .

4.3 Age limit may be relaxed by the Government on the recommendation of the Commission in favour of candidates possessing exceptional qualifications or experience or both.

5. **QUALIFICATIONS :**

5.1 The Candidate must possess the qualification mentioned below or qualification recognised by Medical Council of India as equivalent thereto :

5	Neurosurgery	M.Ch. (Neuro Surgery) AND Four years experience as Associate Professor in Neuro Surgery in a Medical College.
6	General Surgery	M.S.(Surgery)/ M.S. (General Surgery) AND Four years experience as Associate Professor in General Surgery in a Medical College.
7	Nephrology	D.M. (Nephrology) AND Four years experience as Associate Professor in Nephrology in a Medical College.

5.2 Preference may be given to candidates who have to their credit original research publications.

5.3 All medical teachers must possess a basic University or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956).

5.4 Medical Teachers must possess the requisite recognised post-graduate medical qualification in their respective subjects.

5.5 The post-graduate qualifications prescribed for each post shall be deemed to be amended in accordance with the recognition or the de-recognition of such-graduate qualification by the Medical Council of India from time to time.

5.6 50 % of the period spent in recognised research in the subject under the Indian Council of Medical Research or in the University or in the Medical College after obtaining post-graduate degree, shall be counted towards teaching experience if the remaining 50% of the period is spent in regular teaching.

DUTIES & RESPONSIBILITIES : The details regarding duties and responsibilities of the post is available on web site of the Maharashtra Public Service Commission.

7. **GENERAL :**

7.1 Selected candidates will be on probation for a period of two years.

7.2 For the unreserved post other things being equal, preference will be given to candidates belonging to the Backward Classes.

7.3 There are prospects of promotion to the post of Dean, Joint Director and Director of Medical Education and Research, Mumbai in respective subject.

7.4 Selected candidates will be required to sign the agreement embodying the condition of their service including the condition to serve Govt. for a period of 5 years or to pay a penalty of Rs.10,000/- (Rs.Ten Thousand) or such other sum as may be prescribed by Govt.

7.5 As per G.R. Medical Education & Drug Dept.No.MMN-2008/C.R.44/08-MS-2, dt. 27th March, 2008, selected candidates should have to give one option whether to do private practice or to be paid non-practicing allowances in lieu according to the rules.

7.6 Selected candidates will have to get themselves registered under the Maharashtra Medical Practitioners Act, 1961. [Mah. XXVIII of 1961] before joining or his/her name should be borne on the I.M.C. Register under the Indian Medical Council Act, 1956. (CII of 1956), before joining duty.

8. **NOTES :**

8.1 The column No.6.2 of the old application regarding 'Do you claim reservation ' OR column No.5.1 of the new application regarding 'Do you claim benefits of reservation such as Fee, Age and the Post reserved for Backward Categories' shall stand deleted. However, the backward class candidates and general female candidates belonging to the Non-Creamy Layer section will have to claim regarding NCL. In these circumstances, both the applications, old as well as new, submitted by the candidate will be accepted by the Commission.

8.2 In addition the candidates should attach separate sheet of details of qualifications, along with application form, starting from S.S.C., H.S.C. and year wise marks of degree and class etc. of each year as per column 21 or 31 in the application form. Specimen of proforma is available on the website of Commission in ' Specimen Sheet for details of Qualification' Section.

8.3 The Commission at its discretion, may shortlist the applicants for interview based on reasonable criteria, i.e. experience and/or higher qualification, etc. OR may conduct written objective type (multiple choice questions) screening test to shortlist candidates for interview. The syllabus and medium of question paper and other details for the test shall be displayed on the Commission's Website.

8.4 The prescribed essential qualification is the minimum qualification and a mere possession of minimum qualification does not entitle candidates to be called for interview where the number of application received in response to an advertisement is large in numbers and it will not be convenient or possible for Commission to interview all the candidates the Commission may restrict the number of candidates to a reasonable limit on the basis of qualification and experience higher than minimum prescribed in the advertisement.

8.5 Copies of certificates should not be attached with application form. However, candidates are required to furnish an affidavit on a stamp paper of Rs.100/- to be affirmed before Notary in respect of correctness and authenticity of the information mentioned in the application form. Specimen of affidavit is published on the web site in the "Specimen form of Affidavit for Direct Recruitment Posts" section.

8.6 The Application Form should be accompanied by an affidavit, failing which it will be treated as incomplete & will be rejected.

8.7 The candidate should submit all the original certificates alongwith one set of xerox copies of the certificates at the time of interview as per instruction given in Chapter-4 of the Prospectus provided alongwith the Application Form.

9.1 Application must be submitted on the form supplied by the Commission for Direct Recruitment.
