Civil Judge Junior Division and Judicial Magistrate First Class Preliminary Examination - 2011

The Civil Judge (Junior Division) Judicial Magistrate (First Class) Preliminary Examination- 2011 will be held on Sunday, 29th May, 2011 at Aurangabad, Mumbai & Nagpur centers. Online applications are invited by the candidates who are fulfilling the eligibility conditions set out in this advertisement. The candidates qualified in preliminary examination will only be admitted to the main examination.

- 2. No. of Post available: 100
- 3. Pay scale: Rs 27,700 44770 plus other allowances
- 4. Conditions of Eligibility: Age and Qualification-.
 - 4.1 For Advocate, Attorney or Pleader:-
 - 4.1.1 Age: As on 1st August, 2011 not less than 21 and not more than 35 years.
 - 4.1.2 Qualification:-
 - (1) Degree in law and must have practiced as an Advocate, Attorney or Pleader in the High Court or Courts Subordinates thereto for not less than 3 years as on 11th April, 2011.
 - (2) In the case of Public Prosecutors, their service in Maharashtra in that capacity will be considered as practice at the Bar. OR
 - 4.2 For fresh Law Graduates:-
 - 4.2.1 Age: As on 1st August, 2011 not less than 21 and not more than 25 years.
 - 4.2.3 Qualification:-
 - (1) Candidate must has secured the degree in law by passing all the examinations leading to the degree in the first attempt and,
 - (2) Has secured in the final year examination of the degree in Law or in the case of candidate holding Masters Degree (L.L.M) in Law in final year examination not less than 55 % marks as on 11th April, 2011. OR
 - 4.3 Members of ministerial staff to the High Court OR
 - 4.4 Members of ministerial staff to the Courts subordinate to High Court OR
 - 4.5 Members of staff working as Legal Assistant and above in the legal section of the Law and Judiciary Department in Mantralaya. OR
 - 4.6 Members of ministerial Staff of the Office of the Government Pleaders attached to those courts.
 - **4.7 For 4.3, 4.4, 4.5, and 4.6** -As on 1st **August, 2011** not less than 21 and of service after obtaining degree in law on or be fore 11th **April, 2011.**
 - 4.8 Upper age limit will be relaxed:-
 - (1) In case of Backward Class candidates- up to 5 years.
 - (2) In case of persons repatriated from erstwhile East Pakistan from 1st January, 1964 to 25th March 1971, Original Indian repatriated from Shri Lanka after 1st November, 1964 and original Indians repatriated from Brahmadesh after 1st June 1963, up to 3 years.
 - (3) In case of physically challenged (excluding Blind) candidates up to 45 years.[For qualified persons as per the definition of Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.]
 - (4) Blind candidates are not eligible for these posts.

5. Knowledge of Marathi:-

- 5.1 Candidate must have sufficient knowledge of Marathi so as to enable him to speak, read and write in Marathi and to translate with facility from Marathi into English and vice versa.
- 5.2 Such knowledge must be certified -
 - (1) In case of an Advocate, by the Principal District Judge of the District where he practices;
 - (2) In case of a fresh law graduates, by principal or Head of the College or University Department where the candidate was enrolled for LL.B or LL.M.Degree.
 - (3) In case of members of staff, by the Head of the Department/Office under whom such candidate is working.
- (4) In special circumstances by re-employed/ retired Civil Judges (Junior Division).
- (5) The candidates must pass Marathi language test within six months after selection as per Government Rules.

6. Stages of Examination -

- 6.1 This Examination will be held in following three stages:-
- **6.2 Preliminary Examination** -Consisting one question paper of objective type (multiple choices) carrying100 marks. Medium of the examination will be English.
 - 6.2.1 Syllabus for Preliminary examination: -
 - (1) Code of Criminal Procedure. (2) Civil Procedure Code. (3) Evidence Act. (4) Transfer of Property Act (5) Specific Relief Act. (6) Maharashtra Rent Control Act. (7) Limitation Act. (8) Constitution of India. (9) Indian Penal Code. (10) Law of Contracts, Sale of Goods Act & Partnership Act.
 - **6.2.2** The aim of the Preliminary Examination is to Shortlist the number of candidates for main examination. Therefore in all Ten times candidates of total number of posts will be allowed to the main examination as per the merit list of the preliminary examination. As preliminary examination is being screening test, its marks will not be taken into consideration for final selection and will not be communicated to the candidates.

6.3 Main examination

- 6.3.1 Shall be of two hundred marks consisting two papers of 100 marks each. Medium of the examination will be Marathi & English.
- **6.3.2** Candidate who will qualify in main examination as per the Cut Off Line fixed by the Commission will be called for interview. However, candidates must secure 50 marks in each paper & 60% marks in aggregate in main written exam.
- 6.3.3 In case of Scheduled Caste & Scheduled Tribe candidates minimum marks shall be 45 in each paper & 50% in aggregate.
- 6.4 Viva-Voce 50 marks. Candidate who obtains at least 40% marks in viva -voce shall only be considered for final selection.
- **6.5** The final selection shall be made on the basis of marks obtained in Main examination & Viva-Voce.
- 6.6 A candidate who could not successfully pass the written examination in three attempts consecutively shall be debarred from appearing for further examination.

- **6.7** A candidate who has committed any copying or misconduct during course of written examination or has been convicted in criminal case or is compulsorily retired, removed or dismissed from judicial service or could not successfully completed probation period of any course in judicial service shall not be eligible to appear for the Competitive Examination.
- **6.8** The academic qualifications & experience acquired **on the date of publication of Advertisement** will only be taken into account in determining the eligibility of candidates for the posts and for further selection. Academic qualifications shall be deemed to have been acquired on the date on which the result to the relevant examination has been declared by the Competent Authority.
- 7. Candidate selected as Civil Judge Junior Division and Judicial Magistrate First Class, at the time of their appointment shall furnish Bond of Rs.2,00,000/- (Rs.Two Lakhs) that he shall work on said post for period of 3 years

- 9.3 This examination fee will have to be paid by cash in any branch of State Bank of India in working the hours of the Bank after submission of online application form and getting prescribed challan thereof
- 9.4 Submission of online application will not be trated as completed unless transaction Id as received from the Bank on the Challan will not be correctly updated by the candidate through Online Application System

10. How to apply

- 10.1 Applications for this examination will be accepted through online system only. The application submitted other than this mode will not be accepted under any circumstances.
- 10.2 Eligiable candidates must submit their web based online application through www.mpsconline.gov.in from 11th April 2011 to 2nd May, 2011
- 10.3 Detailed instructions regarding submission of online application form are available on www.mpsconline.gov.in. The demo for submission of online application is also available on the same website.
- **10.4** Submittion of application form as prescribed in two phases (online submission of application form and entry of transaction ID after remitting the requisite fee in the bank) must be completed within the prescribed period.
- 10.5 While submitting online application form, candidate must have his lattest photoghraph (width 3.5cm X height 4.5 cm) and his e-mail ID. Candidate should upload his scanned signature and photograph as per the instructions of the Commission.
- 10.6 After login to the www.mpsconline.gov.in through his own user ID and password, candidate should click on Apply Exam/Post button. Then, after apply to JMFC (Pre) Examination 2011; he will have to choose Exam Centre (Aurangabad, Mumbai, Nagpur) After choosing Examination Centre, filling the date and place of submission, the information should be submitted to MPSC by clicking Submit to MPSC button.
- 10.7 After submitting information to MPSC as above, for remittance of prescribed Examination Fee, candidate should click on Print Challan button to get printed copy of Bank Challan. The candidate is required to pay the requisite examination fee mentioned in the challan in any branch of State Bank of India to the cashier alongwith printed challan in the working hours of the Bank. The candidates are requested to take copy of the stamped Challan from the Bank at that time only.
- 10.8 After remittance of requisite Examination Fee through challan, the Transaction Id as given on the Challan by the Bank should be entered as follows:-
 - (1) Candidate is required to login through his own username and password after two working days from the date of remittance of Examination Fee in the Bank..Click on Apply Exam./Post buttom and click on update transaction ID button. Then enter correct transaction ID as given by the Bank. The candidate will be considered for admission to the examination after updating his correct transaction ID and further process will be done. Ohterwise, any further process will not happen.
 - (2) After entering the correct transaction Id as above and if transaction ID as entered if found to be correct, the candidate is required to select Examination sub-centre of that District. After selecting the examination sub-centre, the admission certificate will be provided on the Profile of the Candidate and the same will also be send to his registered email ID. The candidate should take printout of the same.
 - (3) It is mandatory to bring his Admission Certificate with him at the time of examination otherwise he will not be allowed to appear for the examination
 - (4) The candidate applying online need not submit copy of the application or other documents/certificates or affidavit separately.
- 9. The procedure of submission of online application and obtaining a copy of Bank challan for remittance of requisite examination fee should be completed on or before 2nd May, 2011 at 23.59 After that this web link will be disabled.
- 10. Transaction ID received from State Bank Of India after paying examination fee through challan should be updated on or before 5th May, 2011 at 23.59 . After that this web link will be disabled.
- 11. The candidates will not be considered eligible for admission to the examination who do not update their transaction ID correctly within prescribed time and manneras prescribed the MPSC
